- Provides facilitation, writing, research, and analysis for additional projects related to ocean and coastal policy, including those focusing on fisheries, coastal management, and international ocean issues. Duties on these projects include drafting a variety of documents, such as reports, talking points, meeting summaries, and memoranda, and meeting with project participants to understand their perspectives on a range of complex ocean and coastal issues as they relate to project design and execution.
