These collaborative processes address challenges at the local, state, national, and international levels, and involve leaders from government agencies, industry, nongovernmental organizations, and international institutions. Meridian also assists organizations in conducting strategy development and planning.

Manages and facilitates policy dialogues, negotiations, and strategy development projects involving teams of facilitators. - Serves as project manager and co-lead facilitator to assist the 15 Centers of the Consultative Group of International Agricultural Research (CGIAR) conduct an internal assessment process. Conducted interviews with Director Generals, Board Chairs, and Research Program Directors to collect feedback on options for designing the CGIAR research portfolio; convened and facilitated a working group to further explore and refine portfolio design options; and provides ongoing process design

and facilitation support to CGIAR.

- Serves as project manager and lead facilitator for a three-year project with the Climate and Development Knowledge Network (CDKN) to explore consensus building in the UNFCCC through 2015. Activities include convening negotiators twice annually at Conference of the Parties (COP) events and non-COP events with the aim of facilitating discussion and generating ideas for: 1) better understanding the key factors involved in reaching multi-lateral consensus; 2) building negotiator capacity and consensus-building skills; and 3) identifying ways in which the UNFCCC process itself might be changed or better supported to enable agreement. The project regularly publishes *Policy Briefs* based upon negotiator discussion and feedback.
- Served as project manager to develop a comprehensive landscape assessment for the Global Alliance for the Future of Food, a coalition of 20 philanthropic foundations committed to supporting a shift towards sustainable food and agriculture systems. Conducted a literature review to identify critical issues facing sustainable food and agriculture systems; completed interviews with foundation directors; developed an online survey to assess donor priorities; conducted quantitative and qualitative analysis; and served as lead author on the final report. The final report features a foreword by HRH The Prince of Wales and was presented in May 2015 at the International Dialogue: Understanding, Learning and Innovating - The Agriculture and Food Systems Sustainability Challenge in Milan, Italy.
- Served as a core team member of a Winrock International-led multi-year task order contract with the U.S. Department of State to produce a series of Options Assessment Reports (OARs) on critical issues around Reducing Emissions from Deforestation and Forest Degradation (REDD), including the conservation and sustainable management of forests and the enhancement of carbon stocks (REDD+) and land use-related topics that were under discussion in the United Nations Framework Convention on Climate Change (UNFCCC). Managed Meridian's contributions to this effort to design and facilitate consultation processes that led to the development of two OARs: [*Analysis of Approaches for REDD+ Verification*](#) and [*Land Use in a Future Climate Agreement*](#). The program informed negotiators, practitioners, and policy-makers on REDD+ by producing analytic papers on key REDD+ topics in areas relevant to the UNFCCC as well as the implementation of REDD+.
- Served as project manager and facilitator for a three-year series of multi-stakeholder dialogues and objective analyses on the nexus between agriculture and climate change, in the context of the United Nations Framework Convention on Climate Change (UNFCCC) process and other relevant forums. Helped to convene a team of expert authors to develop an independent, objective analysis of key issues on agriculture and climate change, informed by consultations with UNFCCC negotiators, experts, and civil society organizations. This process resulted in the publication of two key reports: *Agriculture and Climate Change Policy Brief: Main Issues*

for the UNFCCC and Beyond (2011) and *Agriculture and Climate Change: A Scoping Report* (2011).

- Served on the Meridian facilitation team working with the U.S. Pacific Command, University of Hawaii, U.S. Department of State, U.S. Chamber of Commerce, National Oceanic and Atmospheric Administration, Federal Emergency Management Agency, and U.S. Agency for International Development to facilitate enhanced coordination and collaboration regarding disaster risk reduction in the Asia-Pacific region.
- Served as project manager and lead facilitator for stakeholder consultations and community consensus building aimed at developing a suite of governance policies for the “dot eco” (.eco) top-level internet domain. Facilitated negotiations and consensus building among a diverse Community Council, comprised of high-level representatives from environmental NGOs and international observer organizations. The project required an in-depth understanding of the internet governance policies of the Internet Corporation for Assigned Names and Numbers (ICANN), the relevant regulatory agency.
- Served as lead facilitator for a series of strategic planning meetings of the U.S. Forest Service’s Interagency Task Team in their development of a National Strategic Framework for Agroforestry. The Strategic Framework identified the most important future emphasis areas for agroforestry research, development, and technology transfer, both nationally and in priority regions and watersheds. It will be used to develop goals for, and guide the future activities of, the U.S. Department of Agriculture’s National Agroforestry Center.
- Served as co-facilitator for the Forum on Readiness for REDD (reducing emissions from deforestation and forest degradation). This Forum sought to effectively engage public, private, nongovernmental, and indigenous stakeholders in finding ways to build capacity in developing countries; foster South-South collaboration; and link local activities with United Nations policy guidance. The project required substantive expertise in REDD+, forestry, climate change, and international policy negotiations.
- Served as part of the Meridian facilitation team for the United States Climate Action Partnership, which led a group of CEOs of Fortune 500 companies, major utility chief executives, and leaders of national environmental organizations through deliberations to develop a consensus set of principles and policy recommendations for U.S. legislation to reduce greenhouse gas emissions.
- Served on a strategy and facilitation team for the Microsoft Critical Infrastructure Protection project. Conducted stakeholder engagement and expert-informed issue mapping of critical infrastructure protection in the electric utility industry.
